Communications were read (1) from Queensland stating that they had decided to adopt the system of allowing the Player to place the ball in a scrummage; so as to be uniform with England, New Zealand and New South Wales.

N.B.—It has been the system in Queensland for the Referee to place the ball in the scrummage at all times.

- (2)—From the Lancashire County Referees' Society, re discussion at their 61st Meeting, in March last, on the following points:—
  - Q. A Forward in the line-out continually knocks the ball on; it is caught by an opposing Half-Back, who smartly punts up the field, gaining much ground each time. Should the Referee allow these kicks?
  - A. The Referee should allow these in accordance with Rule 16. "Unless a fair catch has been made, etc., etc." Note.—In this case the advantage was to kick.
  - Q. A Three-Quarter in making a drop-kick, when running fast, throws the ball forward a couple of yards and then kicks it. Does this constitute a throw forward?
  - A. Yes.
  - Q. In a fading light, a Leading Team is dropping out; the ball drops in touch, and the opposite side order a re-kick; the ball is again dropped into touch, and again a third time. Perceiving that there is a wilful intention to waste time, what course should the Referee adopt other than allowing extra time? See Section K, Rule 2., Page 42. "Should a Referee award a free kick to the opposite side, and, if so, from what point should the kick be taken, etc." The L. R. S., after discussion, referred the question to the English R. U. for decision. The Members of the N. S. W. R. A. decided that the apposing Captain had his remedy under Rule 12, Sec. (a), (b) and (c).
- (3)—Metropolitan Branch, N.S.W.R.F.U., requesting Referees to promptly report any infraction of competition, Rule 3, Page 73, see also Section (b.)
- Members were requested to note that the English ruling, as printed on Page 43, re Try at Goal, has been rejected by the N.S. W.R.F.U., and they have decided that the practice, as heretofore, of allowing the Kicker to place the ball on the ground in instructing the placer should be adhered to.
- MR. PURDY submitted the following question at the previous meeting.
  - Q. A player in the scrummage raises the ball between his knees, an opposing player seeing this wilfully jumps into the pack, with the evident intention of breaking the scrummage, should he be penalised for rough play?
  - A. Yes.

- Q. A Full-back catches the ball from an opponent and makes his mark over his own goal line, does Rule 10 apply to "in goal?"
- A. Law 10 must decide this, the opponents therefore can line up to the mark.
- Q. In the event of a player making a mark in his own "in goal"—say a yard from the dead ball line—and his opponents line up to the mark and charge the kick down over the dead ball line, what should the decision be? "Dead ball" or another kick.
- A. The ball becomes dead!
- Q. Or supposing the charger catches the ball and touches down claiming a try; is this a try or should another kick be allowed?
- A. A try should be scored!

  The attention of Referees is called to the fact that under no circumstances should they allow a player not in possession of the ball to shove another player with his hands.
- Q. A player kicks over full backs head, and, in act of regaining ball, knocks on in his opponents "in goal" and claims a try?
- A. No try, touch down, or dead ball, that is a drop out!
- Q. Re an offside player. The President, Mr. P. F. McManamey, submitted the following question at the previous meeting:—Q. An offside player is within 10 yards of an opponent waiting to receive the ball; but has not approached within 10 yards while offside. Can a free kick be given?
- A. No! Unless the Referee decides that the offside player is intentionally and actively obstructing, or interfering, or until the player has the ball, when a free kick can be given for passively obstructing.
  - Referees are again reminded that teams playing in other than Club Colors must be reported to the Uuion. See Competition Rule 3.
  - Unfinancial Members are requested to forward their Subscriptions on or before Tuesday, June 7th next, otherwise their names will be erased from the roll without further notice.

"We give the ball to the side not committing the breach, that is: 'A' side knocks on, we call out 'B's' ball; this is according to all laws of the game." It was decided that the members of the N. S. W. R. A. adopt the same ruling.
- 3.—Brother Edwin, of St. Joseph's College, Hunter's Hill, asking the following question "A Union Referee gave a free kick against us on account of our Wing-Forward bustling the other Wing-Forward, that is: trying to keep him on side."
- A. The Referee was quite right, as he decided it was illegal tackling.
- Q. Please give a correct definition of "held ball;" must the tackler have one or both hands on the ball.
- A. The ball must be fairly held; that is to say: the player having the ball must use force to free the ball from the grasp of his opponent.
- Q. May a player struggle on after being tackled, provided the tackler has not his hand or hands on the ball.
- A. The player may struggle on, provided the ball has not been held as in previous answer.
- Q. If the tackler brings his opponent to a dead halt, even though the former should not have his hand or hands on the ball, is this "held ball".
- A. No
- Q. A player obtains a mark, and instead of drawing back in a line parallel to the touch-line, but kicked the ball from the place where he had obtained the mark, but kicked in such a manner that its flight was not parallel to the touch-line, is not this allowed. A scrum was given against us.
- A. It was pointed out that the ball could not be kicked from the mark for the reason that the opposing forwards would be lined up to the mark; flight of the ball after the kick matters nothing, the kick must be taken at a spot behind the mark, in a line parallel to the touch-line, and must be in the direction of the opponent's goal line.

- 2.-Mr. Best, Lismore.-
- Q. A ball goes into touch, must the player bringing it into play by means of a "throw in" have one foot on the touch line, or can he stand altogether out of the fleld of play?
- A. Yes! he can stand out of the field of play.
- Q. In the case of a free kick, must the kicker kick over his mark; or can he kick in any direction towards his opponents goal?
- A. He can kick in any direction towards his opponents goal, provided the kick has been taken at a spot behind the mark in a line parellel to the touch line!
- 3.-Waverley Football Club.-
- Q. Can a Referee allow another kick on the plea that owing to interference of players he could not see the ball kicked in the first instance?
- A, Yes!
- 4.-Q. Can a player pick the ball up in the scrum between his knees?
- A. Yes! provided the Referee is satisfied that the player did not fall down in the scrummage.
- 5-Q. When the whistle is blown for a knock on, is it required that a scrum be formed?
- A. No! the ball must be brought back to the spot and there put down.
- 6.-Mr. R. Armstrong-
- Q. Wing forward having the ball for the purpose of putting same in the scrummage calls out with the intention of deceiving the scrum players, "ball is in," and such not being the case, he again calls out "feet off the Ground Umpire," What action should the Referee take?
- A. Free kick against the wing forward, under Law 4, Rule 11, Section J. "wilfully prevents the ball being fairly put into a scrummage?"

Note.—These decisions govern Law 16,—"K Nock-on, Throw-forward," which reads—"In case of a throw-forward or knock-on, the ball shall be at once brought back to where such infringement took place, and there put down, unless a fair catch has been made and claimed, or unless the opposite side gain an advantage. If the ball or a player running with the ball touch the Referee, it shall there be put down."

Mr. Levy-

- Q. Suppose a player in back row of scrum has the ball between his legs, can an opposing player take the ball from its position?
- A. No! Not while said player remains part of the scrum.

Discussion on Lancashire R. S. circulars containing rulings acted on during last season in England, was postponed until next meeting.

The following gentlemen were nominated as new members:—Messrs A. Faulkner, (Q), W. G. Garrard, (N.Z.), A. C. Pilkington, Brooks, Parkinson, G. Hudson, and Barncastle.

A. No goal to be counted and ball still in play!

Q. And should it cross the dead  $\tilde{A}$ . Touch-down; kick out at 25. And should it cross the dead ball line?

Q. Attacking player crosses the goal line and throws the ball forward?

A. A touch-down and kick out at 25.

Q. Mr. H. D. Wood (University Football Club). A scrum is ordered; side A immediately pack; but B's side retain the ball until their forwards gather round leisurely; what should Referee do?

Such incident should be punished as provided by LAW II (eleven) Section J A.

Mr. Hunter. Should a player continually "knock on" or "throw forward" has the Q. Referee a remedy?

Yes; award a Free Kick, under LAW II (eleven), Section K.

Mr. Furniss (Pioneer Football Club). Can a Referee order a player off the field for using the words "You are a nice Referee"?

Yes! he has the power. Referees to note "that under no consideration must a player be allowed to resume play after being ordered off for misconduct."

Mr. Corr (Kings School). A scrum is formed near the line, ball is heeled out by A side, and taken by back player, who is bustled by B's side, and kicks back into

his own, in-touch in goal (not wilfully), what should Referee decide? Provided Referee is satisfied that the kick was not wilful, kick out from 25, i.e. touch down.

Mr. Henson (Pioneer Football Club). Can a Referee over-rule decisions of Touch-Judges?

Yes; he being the sole judge on matters of fact.

Mr. Corr (Kings School). Should a player, having kicked the ball when behind his colleagues, call out "all on side" before such is the case what should the Referee do?

Award a free kick at the spot where such player was when he called out.

Messrs. W. G. Garrard (N.Z.) and A. Faulkner (Q.) were elected as members. Messrs. A. Martin, G. J. Watson, Walpole, and Nicholson, were nominated as members.

Referees are requested to forward results of matches to the Hon. Sec. Metropolitan Branch (Mr. C. M. Drew) as early as possible after matches.

Members who are unable to act this season are requested to notify the Hon. Sec. at once.

A. He decided that the ball was still in play; decision approved of and adopted.

Q. Mr. Sefton. A player brought the ball over the line into the field of play, and threw forward to a colleague. What penalty would be incurred?

A. A scrummage.

Q. A player throws the ball forward from in-goal to a colleague in the field of play. What penalty would be incurred?

A. 5 Yards scrummage.

Note: -The above two questions follow on the play mentioned by Mr. Corr, that is the actions were not intentional

The following were taken from the Lancashire Referee Society's Circular (Mr. H. Williamson, Hon. Sec.)—

2. A player with his arms fully outstretched parellel to the touch line, running at full speed and receiving a pass, draws the ball with his left hand to his right, clear over his head, without leaving his left hand, is this an irregularity?

A. No!

Q. When a half back is in the act of picking up the ball to pass out, the opposing three quarter commences to run to the opposite centre and actually takes the man the instant he catches the ball from the half back.

A. This is offside play and should be penalized.

The above decisions were adopted by the N.S.W.R.A.

The Council of the N.S.W. Rugby Union, have approved of decisions as set out in Circulars 1st and 2nd of this Season.

Note:—No notice will be taken of questions submitted with reference to any particular match by representatives of clubs present; questions must be asked on "The Laws of the Game," and not on "matters of fact," of which the Referee is Sole Judge.

The following points were submitted, and action taken as stated:-

- Q. Mr. Purdy. Can the opposing side have a scrum in lieu of "Throw-in" when ball has gone into in-touch?
- A. Yes; the side to whom the ball belongs may bring it into play by a "Throw-in" or Scrummaging between 5 and 15 yards!
- Q. Canterbury Referees' Association. Mr. W. G. Garrard, Hon Sec. The ball kicked into in-touch, near D's in-goal; A throws-in, all B's side lined out, but A's players were not there, consequently the player waited for his comrades to get into position therefore breaking Rule II (eleven), Sec. K. Where was the Referee to give the Free?
- A. At a point just in the field of play, opposite to the spot where ball went into in-touch and parallel to the touch line.
- Q. Mr. R Armstrong. A Free is awarded, and the ball in its flight is touched by an opponent before crossing the bar, a Touch-Judge for that reason declines to hold his flag up; is he within his rights?
- A. Yes! it is a Touch-Judge's duty to assist the Referee as much as possible.
- Q. Mr. H. D. Wood, University Football Club. Can a player who throws in the ball from in-touch and which alights at right angles; kick or punt it himself?
- A. Yes! even though he is not himself in the field of play.
- Q. Under the same circumstances can he catch it himself?
- A. Yes! if he is in the field of play.
- Q. If when a player drops down on the ball an opponent lifts him off; should there be a penalty inflicted for illegal tackling?
- A No! but if the Referee is satisfied that there has been rough or foul play, he may caution or order off the opponent; and he will of course also give a free kick against the player who dropped on the ball unless he immediately gets up.

The N.S.W.R.F.U. has approved of the 1st and 2nd decisions as set out on the 3rd weekly circular and also the 1st as taken from the Lancashire R.S. Circular; the 2nd has been referred to the Lancashire Society for further explanation. The 3rd and 4th questions have been approved of as per alterations set out hereunder:—

- Q. Mr. Sefton. A defending player thereafter brought the ball over the line into the field of play, and threw forward to a colleague, what penalty would be incurred?
- A. A scrummage.
- Q. The same player throws the ball forward from in-goal to a colleague in the field of play, what penalty would be incurred?
- A. 5 Yards scrummage.

Note. —The words in Italic are the alterations made by the Council.

THE Third Weekly Meeting (Season 1900) of the above, was held at the Rooms, 2 Hunter Street, on Monday, May 28th.

  - A. B's side should be penalised under the following: Law XI, Section (M.)—"Free kicks by way of penalty shall be awarded if any player wilfully or systematically cause unnecessary loss of time." Members attention is particularly called to this decision.
- (2). By Mr. Lound. Q.—"Should a player be allowed to punt the ball when dropping out from the 25 yards' line."
  - A. No; the ball must be drop-kicked, and the game can only be re-started by such kick, unless the Referee is satisfied that the side punting is wasting time.
- (3). By Mr. S. D. Tozer, U.F. C. Q.—"X's side has scored a try and, A., one of their players is placing the ball for a kick at goal; the players of B's side, thinking that the ball is placed, rush it; but A. is allowed by the Referee to replace it; X's side, meanwhile, appeal for 'no charge,' but the Referee still allows a charge." Is it discretionary with the Referee to allow a charge under those circumstances?

A. Yes.

Members present:—Messis. W. Purdy (in the Chair), R. P. Browne, Stockham, Harrington, A. Brown, Holland, Martin, Chapman, McBeath, W. Atkins, Morgan, A. Jones, Lound, Seabrook, Nichols, R. Armstrong, Hunter, Hudson, Brooks, Watson, Treanor, C. Kean, and the Hon. Sec. (R. Kean). Messis. J. R. Henderson, N. Sydney F.C., Cantor, W. M. Arnold, and Weymouth, were also present.

The following rulings are taken from the Lancashire Referees' Society and have been adopted by this Association:—

- Q.—A three-quarter was tackled with the ball, and the forwards quickly formed round him. The Referee saw he was injured, and blew his whistle to let him out. He crept out without breaking up the scrummage. The ball was again put in and played on, one side securing a try. The other side appealed against it claiming that the scrummage should have been reformed.
- A.—A try.
- Q.—A player attempting to make a fair catch, jumps high in the air, catches the ball and, letting on both heels, claims a mark.
- A.-A mark.
- Q.—A player makes a catch, marking with his heel clearly defined, in the field of play, but so near the touch-line that part of his foot was over it. Is this a fair mark?
- A.—Yes.
- Q.—A half back dropped at goal. The ball was touched in flight by an opponent and then rolled dead. Attackers claimed a five yards scrummage, defenders a kick out at 25.
- A.—Kick out at 25. The action being passive.
- Q.—A three-quarter, after making a fine run and going over the line for a try, is held up in goal by a defender. In the compact of the tackle the ball was thrown forward over defender's shoulder on to his back. It then rolled forward a yard or so (towards the dead ball line) and was pounced upon by a member of his side for a try.
- A.—This is no try, being thrown forward, but ranks as a dead ball, and should be kicked off at 25.
- Q.—Now supposing this man stretches his arms over the defender's shoulder and drops the ball on to the tackler's back. It then rolls forward as above. Is this a throw forward?
- A .-- No.
- Q.—Try is made and brought out in usual way for kick at goal. Charge is disallowed. May the ball be taken for a new place, out of the parallel line to the touch-line, from a straight line from where the try was scored?
- A.-No. A new place may be taken, up or down this line, but not away from it.

- Q.—How can any player come up to a scrummage and hook the ball out with his foot without obstructing his opponent's half-back, and how should a Referee proceed should an appeal be made?
- A.—The "hooker-out" must be behind the ball (i.e., on-side). He can follow the ball, and attempt to hook it out in any position, so long as his other foot is behind the ball. In this way there is no illegal obstruction of the half-back.
- Q.—If a three-quarter back gets off-side in front of a scrummage, and is penalized, where must the kick be taken from, where the scrummage was held, or where the three-quarter was off-side?
- A.—Penalty from where the three-quarter is off-side, i.e., where the infringement takes place.
  - The N.S.W.R.F.U. having decided to adopt the English ruling re Kick at Goal, members will please note: "That henceforth the kicker cannot place the ball on the ground in instructing the placer, nor touch it after the placer has put it down, if he does the kick at goal is forfeited."
  - Messrs. J. Treanor and G. Seabrook having passed the examination were duly elected as members.

- A.—A mark.
- Q.—A half back dropped at goal. The ball was touched in flight by an opponent and then rolled dead. Attackers claimed a five yards scrummage, defenders a kick out at 25.
- A.—Kick out at 25. The action being passive.
- Q.—A three-quarter, after making a fine run and going over the line for a try, is held up in goal by a defender. In the compact of the tackle the ball was thrown forward over defender's shoulder on to his back. It then rolled forward a yard or so (towards the dead ball line) and was pounced upon by a member of his side for a try.
- A.—This is no try, being thrown forward, but ranks as a dead ball, and should be kicked off at 25.

- Q.—Now supposing this man stretches his arms over the detender's shoulder and drops the ball on to the tackler's back. It then rolls forward as above. Is this a throw forward?
- A .-- No.

- A.—No. A new place may be taken, up or down this line, but not away from it.
